WHEREAS, the Collective Bargaining Agreement (Blue Unit) (“CBA”) between Teamsters Local 284 and the Ross County Sheriff’s office expires June 30, 2020; and




WHEREAS, any wage increases or other compensation or benefit improvements negotiated for bargaining unit member would be retroactive to the original date of expiration described in Article 47 of the CBA and Paragraph 1, above; now therefore, be it

RESOLVED, the Ross County Commissioners hereby accepts the tentative agreement between the Ross County Sheriff and the Teamsters, Local 284, 2020-MED-03-033 (Blue Unit).



SUBJECTS BROUGHT BEFORE THE BOARD
