OTHER BUSINESS


Sheriff Lavender, Major McKeever and Major White attended the meeting to discuss the need for janitorial service at the Law Complex. They presented a quote from First Capital Enterprises for one supervisor and two crew members, to work 9:00am – 1:00 pm, at an annual cost of \$53,898.24. Commissioner Corcoran suggested hiring another person to the Courthouse Janitorial Staff at \$15.00 per hour would be more financially responsible and could be used in other areas of the courthouse as needed.

Commissioner Garrett has spoken with State Representative Mark Johnson regarding the Capital Grant and the possibility of using those funds to assist in the building of a new Ross County Humane Society.


Ross County Solar – Mr. Chris Snider, of Ross County Solar, LLC gave the Commissioners a copy of the Ohio Qualified Energy Project Tax Exemption Program Application for Certification for the solar project located in Paint and Buckskin Township. Once the application from ODSA is received, the Commissioners will adopt a resolution supporting the PILOT program.
