**OHIO PUBLIC WORKS COMMISSION PROJECT GRANT AGREEMENT PROJECT DOZ02 – COUNTY/TOWNSHIP MULTI ROAD REPAIR**

Mr. Lowe moved, Mr. Corcoran seconded, the Ross County Board of Commissioners approves the act of its Vice President, R. Douglas Corcoran, executing on behalf of the Board and Ross County, as recipient, an Ohio Public Works Commission Project Grant Agreement, Project DOZ02, with the State of Ohio, providing for funding from the Ohio Public Works Commission under the State Capital Improvements Program Fund, in an amount not to exceed \$1,015,851.00 for the County/Township Multi Road Repair project.

**MARINE PATROL ASSISTANCE GRANT AGREEMENT**

Mr. Lowe moved, Mr. Corcoran seconded, the Ross County Board of Commissioners, on behalf of Ross County, Ohio, and by its Vice President, R. Douglas Corcoran enter into a 2022 Marine Patrol Assistance Grant Agreement with the State of Ohio (State), acting by and through the Chief of the Division of Watercraft, providing for grant funding in the amount of \$16,194.03, for the purpose of establishing and/or maintaining and operating a marine law enforcement patrol program in the county to enforce the watercraft laws of Ohio as set forth in Chapters 1547 and 1548 of the Ohio Revised Code, to enforce those regulations, rules and ordinances promulgated by state and local authorities which pertain to the operation of watercraft and to provide emergency response to boating accidents on the water; and, further to authorize the Ross County Sheriff to execute application for withdrawal of funds.

The Commissioners are in receipt of the salaries increase for the Soil and Water Conservation District employees.



